<p>Violation #39. No Contamination (preparation, storage, display) The walk in freezer has food stored on the floor. Store food on shelves. It appears more shelves are needed in the walkin. CODE REFERENCE: 64E-11.003(2). Food shall be protected from sources of contamination and stored in a clean, dry location at least 6 inches above the floor.</p>
<p>Violation #48. Ware washing: installed, maintained, & used; test strips The pans were drying on the towels. Must air dry on non absorbant surfaces or racks. Do not use towels on counter for drying washed plans or dishware. CODE REFERENCE: 64E-11.003(4). Warewashing facilities must be approved, available, maintained, effective, and used for cleaning and sanitizing food-contact surfaces and equipment. Test strips are available and used to verify the solution is at a concentration necessary to achieve sanitization.</p>
